NOTICE INVITING BID

Sealed offers under TWO BID SYSTEM are hereby invited by the Govt. of Arunachal Pradesh from eligible commercial permit holders (Non-scheduled category) for WET LEASE of one Medium (11-13 seater) helicopter for an initial period of 2 (two) years renewable for another year, in prescribed bid form and Performa:-

1. One Twin Engine Medium (11-13 seater) Helicopter of latest technology / latest version having carrying capacity of 9 PAX @ 80 Kgs. + 20 Kgs. Baggage for each passengers excluding pilots, crew and ATF with high altitude flying capacity required for lifting of passengers, VIP, VVIP, patient etc. Annual ceiling of flying hours utilization is 1300 hours i.e. approximate 109 hours per month.

Other terms and conditions and technical parameters require for the helicopters are specified in the detail Tender Documents.
