NOTICE INVITING BID

Sealed offers under **TWO BID SYSTEM** are hereby invited by the Govt. of Arunachal Pradesh from eligible commercial permit holders (Scheduled/Non-scheduled category) for WET LEASE of one large **(MI-172 or equivalent type) helicopter** of following specifications for passenger flight service from Guwahati to Tawang etc. under subsidy scheme of Ministry of Home Affairs, Government of India, for an initial period of **1 (one) year** with option of renewal for **another year** at the same rates, terms & conditions subject to continuation of subsidy support by the Ministry of Home Affairs, Government of India, in prescribed bid form and proforma:-

1. One Twin Engine Large Heavy Duty Transport Helicopter having carrying capacity of 24 PAX @80 Kgs. + 20 Kgs Baggage for each passengers excluding pilots, crew and ATF with high altitude flying capacity for lifting of passengers, VIP, VVIP, patient etc. in high altitude locations like Guwahati-Tawang route. Monthly ceiling of flying hours is 52 hours.

2. Bidder is to deposit **Bid Bond (Earnest Money)** of **Rs.20.00 (twenty) lakh** in the form of Bank Guarantee as specified in the Detailed Tender Documents.

Other terms and conditions and technical parameters required for the helicopters are specified in the Detailed Tender Documents.

3. Detail Tender Documents may be had from the Office of the Commissioner (Civil Aviation), Govt. of Arunachal Pradesh, Itanagar **from 29.4.2008 to 28.5.2008 during office hours from 1000 hours (IST) to 1600 hours (IST)** against a request/authority letter.
4. Detail Tender Documents may also be collected by post by sending a self addressed stamped envelop **or** by down loading it from the website- WWW.arun-aviation.nic.in. The Government of Arunachal Pradesh will however not be responsible for non-reaching of the Tender Documents due to postal delay or misplacement etc.
5. **Last date and time of receipt of Tender** by post or by hand is **1200 hours (IST)** on **29.05.2008** in the office of Commissioner (Civil Aviation), Govt. of Arunachal Pradesh, Itanagar.
6. **a) Sealed Tenders will be opened** in the office chamber of Commissioner (Civil Aviation), Govt. of Arunachal Pradesh, Itanagar at **1300 hours (IST)** on **29.5.2008** by a board constituted by the Government of Arunachal Pradesh. If intervened by a holiday, Tenders will be received /opened at the same time on next working day.

b) After opening of Sealed Packets of Tenders, **only the Un-price (Technical) Bids shall be opened on 29.05.2008** for scrutiny of the bid documents and technical data etc. **The Price Bids shall be opened on 30.05.2008 (or next working day) at 1000 hrs** by the Board. **However, if Un-price Bid of any bidder is found incomplete, not supported by Bid Bond and/or required documents or deficient of any technical parameter as specified in the Detailed Tender Documents, their Price Bid shall not be opened on 30.05.2008 and shall be returned to the bidder in sealed condition as submitted by the bidder.**

7. **The Government of Arunachal Pradesh reserves the right to reject any or all the offers without assigning any reasons thereof.**
